

# REGISTRATION APPLICATION & RENEWAL FORM

The Denver Mart is open to professional buyers in the retail or interior design trade only.

**Please Note:** Use this form if you are a first time buyer or are renewing your account.

## RETAIL BUYERS AND INTERIOR DESIGNERS *required with each application:*

1. **Copy of current state retail sales tax license**
2. **Business license or Federal ID** for businesses in the states of Alaska, Delaware, Montana, New Hampshire and Oregon only.
3. **Proof of ownership** - an official document that has your personal name and your company name on the document. You may also obtain a vendor referral as proof of ownership
4. **Proof of business banking** – a voided business check **or** a business credit/debit card with your name and your company name imprinted on the card with the account number blacked out.
5. **Adding buyers to your account:** Current payroll stub for each buyer that shows withholdings and a year to date **or** a business credit/debit card with the employees name and your company name imprinted on the card with the account number blacked out.

**Interior Designers:** Current ASID, IIDA, NKB, NCIDQ or proof of other related professional membership.

**Colorado Retail Businesses:** Expiration date of your account will be the same date your retail sales tax license expires which is the last day of the year on every odd year. (Example: 12/31/2019, 12/31/2021, etc.)

**All Other States:** Expiration date of your account will be two years from the application approval date at the end of that given month. (Example: application date 9/10/2019, expiration date 9/30/2021)

## RENEWAL REQUIREMENTS *required with each renewal application:*

1. **Copy of current state retail sales tax license**
2. **Business license or Federal ID** for businesses in the states of Alaska, Delaware, Montana, New Hampshire and Oregon only.
3. **Proof of ownership** - an official document that has your personal name and your company name on the document. You may also obtain a vendor referral as proof of ownership
4. **Proof of business banking** – a voided business check **or** a business credit/debit card with your name and your company name imprinted on the card with the account number blacked out.
5. **Adding buyers to your account:** Current payroll stub for each buyer that shows withholdings and a year to date **or** a business credit/debit card with the employees name and your company name imprinted on the card with the account number blacked out.

**Interior Designers:** Current ASID, IIDA, NKB, NCIDQ or proof of other related professional membership.

### PLEASE NOTE THE FOLLOWING:

- Passes are **non-transferable**. They should not be given to other people as they will be denied entrance.
- **Designers must accompany all clients** or may make a showroom appointment for a client. The showroom will take responsibility for escorting the client to and from that showroom.
- **THREE GUEST MAXIMUM AND FEE POLICY DURING EVENTS**
- 1st guest no charge, 2nd and 3rd guests \$35.00 fee. Payable in cash or by Credit Card in Main Mart Lobby. Guests must stay with a registered Buyer at all times.
